Please refer to your online RTI applications Registeration No. 6898 & 6899 both dated 27.03.2019 on the above subject that has been received by CPIO in the Commission on 03.04.2019. The information sought by you is in nature of clarification/explanation, which is not covered under the meaning of "information" as defined under Section 2(f) of the RTI Act, 2005. However, it is stated that the Commission's instructions vide letter No. 464/INST/2009/EPS dated 16.02.2010 are still valid, wherein it has been stated that "Group 'A' or equivalent Senior Officers including teaching staff of Universities. College etc should not be drafted for "Polling duties" in polling station premises without specific reasons to be recorded in writing by the District Election Officer, where such appointments become unavoidable." These instructions are self-explanatory.

In view of above, it is evident that aforesaid Government employees can be drafted for election duty with specific reasons to be recorded in writing by District Election Officer, where such appointments become unavoidable. The details of the First Appellate Authority are as under: -

Sub: Request to exempt me from the duties allotted upon me for upcoming Panchayet Election

Sir / Madam,

I, the undersigned, a State Aided College Teacher of ............................... College like to draw your kind attention of a serious problem faced by me as you have sent me an appointment letter to do election duties on upcoming panchayet election.

Sir/ Madam, though I am teaching in a college, but I am not a fulltime college teacher. I am a contractual employee engaged in a notional post, i.e., the said post will be abolished when I will get retired. Like the fulltime employees, we have no pay scale, Provident Fund, service book, death benefit, pension etc. and even we are not the members of Teachers' Council or Governing Body.

Since, I am a contractual employee and according to order of Election Commission (Section 6 of the West Bengal State Election Commission Act, 1994 and Section 28(1) of the West Bengal Panchayet Election Act, 2003 Dated, the contractual workers or Anganwadi workers not to be engaged in election, so I earnestly request to exempt me from taking election duties according to the said order published by the election commission. Moreover, Hon'ble Calcutta High Court also given a judgement on 13.06.2023 where Hon'ble Justices also exempt the contractual employees from election related duties.

I, therefore, request you according to the orders of Election Commission and the abovementioned judgement of Hon'ble Calcutta High Court, stop engaging me from election duties as I am a contractual employee.
