We, on behalf of West Bengal College and University Teachers' Association (WBCUTA) welcome the steps already taken by the Government of West Bengal towards implementation of new pay scale for state govt. employees along with school teachers and non-teaching employees of the Universities and Colleges of the State.

You are aware that 7th UGC Pay Scale for the teachers and equivalent cadres in University and Colleges was declared in the year 2017 and it has already been implemented in most of the states across the country.

On behalf of West Bengal College and University Teachers' Association (WBCUTA) we request you to kindly take necessary steps towards implementation of 7th Pay Revision of University and College Teachers of West Bengal.

We the teachers in Colleges and Universities have not drawn any interim relief from Govt. of West Bengal so far in view of this Revision of Pay.

In this connection we would like to mention the letter [F.No. 23-4/2017(P.S.)] dated 31st January, 2018 sent by Mr. P.K.Thakur, Secretary UGC, to the Education Secretaries of all the States across the nation for necessary steps towards implementation of new UGC Pay Scale.
